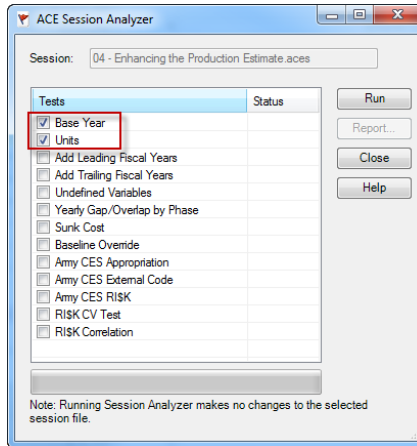

Tip of the Month

Do you ever need to change the Base Year and/or Units of your session?

You can easily change this information on the General tab of Session Properties, but you should take a few minutes to make sure the change works as expected.

ACE has a session review tool that ensures all your costs have been properly specified. The **Session Analyzer** (accessed from the Construction ribbon) has many useful tests; when changing BY and units, you only need to run the first two tests: Base Year and Units



After selecting tests, click Run. If there are any warnings in the session, ACE generates a report to show you which rows have possible issues. You should first focus your attention on **bold** rows since these are lowest level child rows, often input variables. Fixing these often fixes other rows. You can export the report to Excel by clicking the Export icon at the top of the form. This way you can see the error report as you fix the issues in the session.

You get hands-on experience with built-in wizards that simplify the task of defining uncertainty and correlation. And you will use the automated health checks to identify errors, determine schedule, cost and uncertainty conflicts, and flag where best practices are not being used. Learn how to generate a variety of graphical reports to analyze Joint Confidence Level (JCL) results and to identify cost, schedule and uncertainty drivers.
