## **ACEIT 8.2 Release Available!**

We are thrilled to announce the launch of our latest software update ACEIT 8.2. ACEIT 8.2 is a major update designed to provide enhanced capabilities for working with inflation and escalation. It includes updating ACEIT terminology to be consistent with the Office of the Secretary of Defense Cost Assessment and Program Evaluation (OSD CAPE) "Inflation and Escalation Best Practices for Cost Analysis Analyst Handbook" dated December 2021. Our ACEIT team has worked diligently to ensure that ACEIT continues to support the cost estimating community's best practices. Therefore, the new inflation and escalation features and enhancements were implemented across all ACEIT applications. We also included multiple new features to help users transition files to the new best practices.

### **Highlights of the update include:**

- Terminology updates to align with the CAPE handbook including: cost type inputs, functions, results, sunk costs, overrides, reports and charts.
- New Constant Year cost types for obligations and expenditures.
- File transition review and documentation.
- Enhanced labeling of inflation and escalation indices.



JACS users can also see many new improvements. You can check out the new interface in the JACS Application. The JACS Application incorporates functionality from JACS P6 and JACS Add-in. In addition, many charts from JACS Observer are added to JACS Insight.
