Subject: Obtaining ACEIT as a Government Furnished Software (GFS)

To request ACEIT as GFS for your site, you and your U.S. Federal Government sponsor must complete and sign the enclosed "Certification for Release of ACEIT as Government Furnished Software to a U.S. Government Support Contractor (Form CTR-1). Once the CTR-1 is approved by your U.S. Federal Government Sponsor, enter the relevant information on the enclosed "Software Release Agreement".

If you wish to use ACEIT on any other task other than that specified by your sponsor, then you must purchase a license. If that is the case, please refer to the "Purchase" page at our website [www.aceit.com](http://www.aceit.com) for further information.

The ACEIT Government Program Office, Air Force Life Cycle Management Center (AFLCMC HAOL/FZC) has asked Tecolote Research, Inc. to recoup a fair share of the ACEIT distribution, maintenance and support (DMS) costs from each ACEIT site. Since your sponsor has no support contract with Tecolote Research, Inc. to distribute ACEIT on their behalf, you must pay an annual fee for ACEIT DMS. If you are not sure that your sponsor has a DMS support contract with Tecolote Research, Inc., please feel free to contact us to find out.

When we receive your completed CTR-1 form signed by your sponsor, a "Software Release Agreement" signed by you and a completed "ACEIT DMS Order Form", we can provide ACEIT to you as GFS. As the software release agreement states, if you do obtain ACEIT as GFS, you are permitted to use ACEIT only for the project, contract, and time period specified by the government sponsor on the CTR-1 form.

### U.S. GOVERNMENT AND U.S. GOVERNMENT SUPPORT CONTRACTOR ACEIT SITE RESPONSIBILITIES

#### ACEIT RELEASE POLICY

The software, data, and documentation are available for use by the U.S. Government and its certified support contractors. However, unless the government organization has an ACEIT support contract with Tecolote Research, Inc. each of its sites and its support contractors must pay an annual fee for distribution, maintenance, and support (DMS) of ACEIT software, data, and documentation before they receive the software. DMS fees for subsequent years are optional if the organization elects to use its existing version of the software, data, and documentation with no further distribution of updates or use of technical support. All other entities must obtain an annual license from Tecolote Research, Inc. to use the software (DMS is included with the license fee).
