Description:

Automated Cost Estimating Integrated Tools (ACEIT) 8.x consists of a family of applications that support Program Managers and cost/financial Analysts with developing Life Cycle Cost Estimates (LCCEs) during all phases of acquisition I and II programs. ACEIT 8.x suite includes Automated Cost Estimator (ACE), and these main Microsoft Excel add-in applications CO\$TAT, Program Office Support Tool (POST), Joint Cost and Schedule Analysis (JACS), and Librarian. ACE is the estimating portion and heart of the ACEIT application suite. ACE is a model-building tool for Analysts to develop and calculate cost estimates. ACE integrates with RI\$K which is a simulation-based uncertainty analysis capability feature used to perform cost, schedule, and technical risk and uncertainty analysis. CO\$TAT is the statistical analysis feature of the ACEIT application suite that allows users to navigate through the analysis process to develop estimating relationships such as cost and price analysis and include the analysis directly into the final cost estimate. POST provides new inputs to an existing ACE session, execute the underlying ACE session on these inputs, view ACE output results, and create reports in XML-based file containing all the calculated results for a what-if cases assessed. The Librarian automatically builds and maintains methodology libraries containing analogies, factors, equations, rules, and references.

ACEIT 8.x is installed on a current Secure Host Baseline-Army (SHB-A) build workstation. The user accesses the application from the shortcut in the Windows Start menu or from the desktop icon. The user manually enters data into the application via keyboard and mouse. Data is saved on the local hard or shared drive, and data stays internal to the local enclave.
